# ORDINANCE OF FOX RIVER AND COUNTRYSIDE FIRE/RESCUE KANE AND DUPAGE COUNTIES, ILLINOIS LEVYING AND ASSESSING TAXES FOR 2022

WHEREAS, this Ordinance shall be designated and known as The Tax Levy Ordinance of the Fox River and Countryside Fire/Rescue, Kane and DuPage Counties, Illinois (District) for the year 2022; and

WHEREAS, the Board of Trustees of the District hereby find it necessary to raise by general taxation those amounts hereinafter set forth to be levied upon all the taxable property within the Fox River and Countryside Fire/Rescue to meet and satisfy the necessary expenses and liabilities of the District.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Fox River and Countryside Fire/Rescue, of Kane and DuPage Counties, Illinois as follows:

<u>Section 1</u>: The foregoing recitals are hereby adopted as the findings of the Board of Trustees of Fox River and Countryside Fire/Rescue as if fully-- restated herein.

Section 2: That the sum of \$4,596,977.00 be and the same is hereby assessed and levied from and against all the real property within the limits of the Fox River and Countryside Fire/Rescue, subject to taxation according to the ad valorem value of the said property after the same is assessed and equalized for State and County purposes; said taxes hereby levied being for the current year 2022, and to be extended and levied for the 2022 tax year. That a Combined Budget and Appropriation Ordinance for said fiscal year was adopted by the District within the first quarter of the fiscal year 2022 in compliance with all statutory requirements.

Section 3: The objects and purposes and the respective amounts levied for the various funds are set forth hereafter and the tax so levied for said fiscal year is in the total aggregate sum as set forth above and is as follows:

The foregoing amount is hereby levied for emergency/rescue expense purposes pursuant to the provisions of 70 ILCS 705/24.

#### **BOND AND INTEREST**

Bond and Interest

The foregoing amount is hereby levied for the purposes of repayment of bonds pursuant to the provisions of 70 ILCS 705/13.
