ORDINANCE NO. 2024-01

AN ORDINANCE OF THE FOX RIVER & COUNTRYSIDE FIRE / RESCUE DISTRICT <u>ESTABLISHING THE OFFICE OF DEPUTY CHIEF</u>

WHEREAS, the Fox River & Countryside Fire / Rescue District (the "District") is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees of the District (the "Board") has full power pursuant to 70 ILCS 705/6, to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board for carrying into effect the objects for which the District was formed; and

WHEREAS, the Board desires to create the new office of Deputy Chief.

THEREFORE, BE IT ORDAINED by the Board of Trustees of the Fox River & Countryside Fire / Rescue District as follows:

SECTION 1: The office of Deputy Chief is created effective immediately.

SECTION 2: The Deputy Chief shall report to the Fire Chief and hold the duties and responsibilities as the Board or Fire Chief shall establish and modify from time to time.

SECTION 3: The Deputy Chief shall be compensated as prescribed separately by the Board.

SECTION 4: This Ordinance shall supersede any ordinances or motions or parts of ordinances or motions in conflict with any part herein, and any such ordinances or motions or parts of such ordinances are hereby repealed.

SECTION 5: If any section, paragraph or provisions of the Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.

SECTION 6: The provisions of this Ordinance shall be in full force and effect immediately upon adoption.
