ORDINANCE NO. 2020-06

AN ORDINANCE DISCONNECTING CERTAIN TERRITORY PURSUANT TO 70 ILCS 705/16d (Kautz Road properties)

WHEREAS, the Fox River and Countryside Fire Rescue District, Kane County, Illinois (the "District") is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees (the "Board") of the District has full power to pass all necessary ordinances and rules for the proper management and conduct of District business pursuant to 70 ILCS 705/6; and

WHEREAS, the Board finds that the property identified in Exhibit A and depicted in Exhibit B, commonly identified as the Kautz Road properties, is currently within the Fox River and Countryside Fire Rescue District; and

WHEREAS, the property identified in Exhibit A consists of an area smaller than 60 acres; and

WHEREAS, 70 ILCS 705/16d allows the boards of trustees of two adjoining fire protection districts to transfer territory of no more than 60 acres by ordinance, upon agreement, after advance notice to the affected property owners [70 ILCS 705/16d]; and

WHEREAS, the Board has found that the territory identified in Exhibit A meets the qualifications set forth by 70 ILCS 705/16d to be disconnected from the District and annexed into the West Chicago Fire Protection District; and

WHEREAS, the Board has provided advance notice of the intended disconnection to each property owner as required by statute, with a copy of one such notice attached hereto as EXHIBIT C; and

WHEREAS, the Board finds good and ample cause exists to disconnect from the District by ordinance the property identified and legally described in the attached **EXHIBIT A**.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Fox River and Countryside Fire Rescue District, Kane County, Illinois as follows:

<u>Section One</u>: The Board of Trustees of the District hereby finds that the properties identified and legally described in **EXHIBIT A** attached hereto (the "Subject Properties") meet the qualifications of 70 ILCS 705/16d, in that:

- A. The territory consists of 60 acres or less; and
- B. The territory is adjacent to the West Chicago Fire Protection District but contained wholly within the Fox River and Countryside Fire Rescue District; and
- C. The West Chicago Fire Protection District is better equipped to provide the services to the subject property due to its location.

Section Two: The Board, after giving the property owners proper notice and an opportunity to be heard, hereby disconnects from the District the Subject Properties legally described in **EXHIBIT A**, effective January 1, 2021.

<u>Section Three</u>: The Fire Chief or designee is hereby authorized and directed to file a certified copy of this Ordinance with the Kane County Clerk and the State Fire Marshal, and to record this Ordinance with the Kane County Recorder.

<u>Section Four</u>: The provisions of this Ordinance shall be in full force and effect upon the adoption and signing of the Ordinance.

<u>Section Five</u>: This Ordinance shall supersede any ordinances, resolutions, motions, or parts of ordinances, resolutions, or motions in conflict with any part herein, and any such ordinance, resolution or motion or parts thereof, are hereby repealed to the extent of any conflict.

<u>Section Six</u>: If any section, paragraph or provision of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or inability to enforce any portion shall not affect any of the remaining provisions of this Ordinance.


