**ORDINANCE OF FOX RIVER AND COUNTRYSIDE FIRE/RESCUE
KANE AND DUPAGE COUNTIES, ILLINOIS
LEVYING AND ASSESSING TAXES FOR 2016**

WHEREAS, this Ordinance shall be designated and known as AThe Tax Levy Ordinance of the Fox River and Countryside Fire/Rescue, Kane and DuPage Counties, Illinois@ (ADistrict@) for the year 2016; and

WHEREAS, the Board of Trustees of the District hereby find it necessary to raise by general taxation those amounts hereinafter set forth to be levied upon all the taxable property within the Fox River and Countryside Fire/Rescue to meet and satisfy the necessary expenses and liabilities of the District.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Fox River and Countryside Fire/Rescue, of Kane and DuPage Counties, Illinois as follows:

Section 1: The foregoing recitals are hereby adopted as the findings of the Board of Trustees of Fox River and Countryside Fire/Rescue as if fully-- restated herein.

Section 2: That the sum of \$2,562,600.00 be and the same is hereby assessed and levied from and against all the real property within the limits of the Fox River and Countryside Fire/Rescue, subject to taxation according to the ad valorem value of the said property after the same is assessed and equalized for State and County purposes; said taxes hereby levied being for the current year 2016, and to be extended and levied for the 2016 tax year. That a Combined Budget and Appropriation Ordinance for said fiscal year was adopted by the District within the first quarter of the fiscal year 2017 in compliance with all statutory requirements.

Section 1: The foregoing recitals are hereby adopted as the findings of the Board of Trustees of Fox River and Countryside Fire/Rescue as if fully-- restated herein.

Section 2: That the sum of \$2,562,600.00 be and the same is hereby assessed and levied from and against all the real property within the limits of the Fox River and Countryside Fire/Rescue, subject to taxation according to the ad valorem value of the said property after the same is assessed and equalized for State and County purposes; said taxes hereby levied being for the current year 2016, and to be extended and levied for the 2016 tax year. That a Combined Budget and Appropriation Ordinance for said fiscal year was adopted by the District within the first quarter of the fiscal year 2017 in compliance with all statutory requirements.

Section 3: The objects and purposes and the respective amounts levied for the various funds are set forth hereafter and the tax so levied for said fiscal year is in the total aggregate sum as set forth above and is as follows:

Corporate Fund Levy \$1,777,000.00
The foregoing amount is hereby levied for corporate expense purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE SERVICE FUND

Ambulance Service Fund Levy \$392,800.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

EMERGENCY/RESCUE FUND

Emergency/Rescue Fund Levy \$392,800.00

The foregoing amount is hereby levied for emergency/rescue expense purposes pursuant to the provisions of 70 ILCS 705/24.


Section 3: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.





I, Bob Handley, hereby certify that I am President and Chief Presiding Officer of the Board of Trustees of the Fox River and Countryside Fire/Rescue, Kane and DuPage Counties, Illinois, and, as such, I hereby certify that the 2016 tax levy ordinance, a copy of which is appended hereto, was adopted pursuant to, and in all respects in compliance with, the provisions of the Truth in Taxation Law, 35 ILCS 200/18-60 through 18-85.

The provisions of Sections 18-60 through 18-85 of the Truth in Taxation Law are inapplicable to the Fox River and Countryside Fire/Rescues' 2016 tax levy. The District was not required to publish its advertisement and hold a public hearing on its proposed levy in accordance with the law.
