**A RESOLUTION SETTING THE REGULAR MEETING DATES FOR THE

WHEREAS, Section 2.03 of the Act provides that each public body subject to the Act must prepare and make available a schedule of all its regular meetings for such calendar or fiscal year; and

WHEREAS, the Fox River & Countryside Fire/Rescue District (the "District") is a public body subject to the requirements of the Act; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE FOX RIVER & COUNTRYSIDE FIRE/RESCUE DISTRICT, KANE AND DUPAGE COUNTIES, ILLINOIS, *as follows:*

Section 1: The facts and statements set out in the preamble to this Resolution are hereby found by the Board of Trustees of the District to be true and correct and are hereby adopted and incorporated as part of this Resolution.

Section 2: The schedule of regular meetings of the Board of Trustees of the District for the calendar year 2019 shall be as set forth on Schedule "A" attached hereto and made a part hereof as if fully set forth. All regular meetings shall be at **34W500 Carl**

Lee Road, St. Charles, Illinois 60174 and shall convene at the hour of 7:00PM local time unless otherwise published.

Section 3: Notice of such regular meetings and the schedule of meetings attached hereto shall be given by the Secretary of the District to all news media that have filed an annual request for such notice with the Secretary of the District.

Section 4: This Resolution shall be in full force and effect from and after its passage.


