**RESOLUTION 2017 – 05**

**A RESOLUTION  
PROVIDING FOR THE SUBMISSION OF A BINDING PUBLIC  
QUESTION TO INCREASE THE EXTENSION LIMITATION FOR THE  
FOX RIVER & COUNTRYSIDE FIRE/RESCUE DISTRICT TO BE  
SUBMITTED TO THE ELECTORS OF THE DISTRICT AT  
THE GENERAL PRIMARY ELECTION TO BE HELD MARCH 20, 2018**

**WHEREAS, the FOX RIVER AND COUNTRYSIDE FIRE/RESCUE DISTRICT (hereinafter the “DISTRICT”) is a municipal corporation and body corporate of the State of Illinois, duly organized and existing under the provisions of the Fire Protection District Act, 70 ILCS 705 (2012) (the “Act”); and**

**WHEREAS, the DISTRICT is empowered by the Act to exercise all powers necessary or appropriate in order that they may engage in the acquisition, establishment, maintenance and operation of fire stations, facilities, vehicles, apparatus and equipment for the prevention and control of fire therein and the underwater recovery of drowning victims, and provide as nearly adequate protection from fire for lives and property within the districts as possible and regulate the prevention and control of fire therein; and**

**WHEREAS, the Act provides that the powers aforesaid conferred upon such fire protection districts are public objects and governmental functions in the public interest; and**

**WHEREAS, the Board of Trustees of the District has determined that it is the best interest of the residents and property owners within the District that a proposition to increase the extension limitation for the District be submitted to the electors of the District to be voted upon at the March 20, 2018 General Primary Election;**

**NOW, THEREFORE BE IT RESOLVED by the BOARD OF TRUSTEES OF THE FOX RIVER AND COUNTRYSIDE FIRE/RESCUE DISTRICT, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:**

**SECTION 1. The facts and statements contained in the preamble to this Resolution are hereby determined by the Board of Trustees of the District to be true and correct, and are hereby incorporated herein as if fully set forth.**

**SECTION 2. The Board of Trustees of the DISTRICT hereby resolves to submit the following binding public question to the electors of the District to be voted upon at the General Primary Election to be held on March 20, 2018.**

**“Shall the extension limitation under the Property Tax Extension Limitation Law for the Fox River & Countryside Fire/Rescue District, Kane and DuPage Counties, Illinois, be increased from the lesser of 5% or the percentage increase in the Consumer Price Index over the prior levy year to 60% per year for the 2018 levy year?”**

**SECTION 3. The ballot submitted shall have printed thereon, but not as a part of the question submitted, only the following supplemental information:**


**Supplemental Information Submitted Pursuant to 35 ILCS 200/18-205**

**For the 2018 levy year the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$ 53.00.**

**SECTION 4. This Resolution shall be in full force and effect from and after its passage, and shall be certified by the Secretary or his designee with the appropriate Election Authorities within the time provided by law for submission to the electors of the District at the March 20, 2018 General Primary Election.**

**SECTION 5. The President and the attorney for the District are authorized and empowered to make non-material corrections to the Supplemental Information set forth in Section 3 of this Resolution based upon new or corrected information available to the District, to the fullest extent permitted by law.**
